INCIDENT DESCRIPTION

Somebody stole approximately 30 yards of river gravel near our community compost pile. It must have been very recently.

Jake Kimbrough, our HOA maintenance employee, was working near the scene where I discovered the missing gravel, so I asked if he knew who stole the gravel. Jake said it was taken by someone who had their own trailer and small tractor but he did not know their name. He said Don Begines would probably know the person who stole the gravel.

In addition to the value of the stolen property, this gravel was stolen from an area of our community property that is designated wetlands.
